# Government Consultation

---

The following is a notice from the Government of New Brunswick regarding their consultation on the review of the *Family Services Act* in relation to child and youth welfare.

"Hello

The provincial government is seeking input from New Brunswickers on a review of the child and youth welfare provisions of the *Family Services Act*.

To help New Brunswickers share their thoughts on the matter, the Department of Social Development has launched a discussion paper which includes guiding questions that cover key concepts to focus feedback and input from those interested in identifying what should be included in new child welfare legislation.

Those interested in participating in the consultation can choose to submit a brief or respond to the questions in the child welfare law reform Discussion Paper. The Discussion Paper is available until February 28, 2020 on the [Citizen Engagement and Consultations](#) page of the Government of New Brunswick website.

## Horizon Community Innovation Grant

Horizon's Community Innovation Grant (COIN-G) is a grant program for community stakeholders in partnership with Horizon to fund initiatives or projects within local communities. This grant supports Population Health related projects that focus on the Social Determinants of Health, and where possible, respond to the priorities determined through the Community Health Needs Assessments.

Funding is open to any project impacting community health. If a project is community led, it will require the sponsorship of a Horizon employee. The following

conditions make for a stronger application.

Applications for small grants (under \$1000) continue to be accepted at any time throughout the year.

Deadline for applications for large grants (\$10,000) is February 15, 2020.
