Through critical thinking and reflective analysis, students learn to assess complex social issues and apply evidence-informed approaches. The core learning objectives also cultivate research and inquiry skills, which are essential for evaluating practice and contributing to knowledge in the field.

General Liberal Arts and Social Sciences Education²

General Liberal Arts and Social Sciences Education provides students with foundational knowledge of key disciplines related to social work. This foundational general training ensures an introduction to their concepts and terms used, as well as knowledge of internal and external factors that contribute to the explanation of social and psychosocial problems. It also ensures the development of formal intellectual and cognitive skills, mastery of oral and written languages, open-mindedness, critical thinking, and the capacity for analysis and synthesis.
