According to the *Policy on the Supervised Learning Period when 140 or more hours of field work are missing,* this self-assessment must be completed and signed by the candidate and supervisor. The self-assessment must be submitted directly to the NBASW by the supervisor.

If the candidate is unable to have the form certified by a supervisor, the candidate may ask the employer to provide such attestation. If this option is also unavailable, the candidate must provide the details of the reasons in the "Additional Comments" section of the self-assessment form. Each self-assessment will be judged on its merits, according to the information provided.

If the professional experience involves various jobs, a professional experience form must be completed for each experience, clearly indicating the place of work, the position, and the length of the professional experience. As indicated in the policy, the candidate's professional experience will be assessed only if the candidate has worked during the five years preceding the application.

Candidates are advised to consult the NBASW <u>Scope of Practice</u> and <u>Code of Ethics</u> before filling out this form to gain a better understanding of the way work experience applies to social work practice in New Brunswick.
